4. Show a friendly spirit of cooperation with my fellow professional photographers and assist them whenever possible, should they be in need.
5. At all times avoid the use of unfair competitive practices.
6. Assist and provide my knowledge to members of my profession and encourage them individually and collectively, so that the quality of photography may constantly be raised to higher standards.
7. In all matters relating to the interpretation of this code, will recognize the authority of the board of directors of Indian Nations Professional Photographers Association.
